Section 38-431.03(A)(4) re:
 - A. Talking Rock Land, LLC vs ICRSD, Case No. P1300CV201800380 and Case No. P1300CV201900298 including, but not limited to: the remand to the lower court; possible mediation negotiations with Developer; Possible direction to the attorneys of the Inscription Canyon Ranch Sanitary District relating to the mediation and mediation -related issues, and the latest settlement offer from Talking Rock Land, LLC.

CHAIRMAN'S REPORT

The Chairman, Mr. Summers, read the following:

As I stated last meeting, some of the 2021 ARP money Yavapai County will receive will be set aside for infrastructure improvements, this includes Sanitary plant improvements. I have been contacted by Yavapai County to advise me they have received the ICR Sanitary District letter expressing interest in the 2021 ARP program and that they will keep the District informed. It sounds like the County will be developing an application process and this may take the County up to 6 months to finalize. The Sanitary District will be contacted as this application process is completed so your Sanitary District can apply for 2021 ARP funds. At this point, I believe the funds will be distributed in the form of grants, not loans. Thank you for your time.

MANAGER'S REPORT

Mr. Busch reported that Mr. Tom Severson initially submitted incomplete Capacity Assurance forms but has since made the necessary revisions and has resubmitted them to the District and currently await Board approval.

Mr. Summers also stated that Mr. McLeod was researching funding possibilities with the US Department of Agriculture.

7. NEW BUSINESS - DISCUSSION & POSSIBLE ACTION RE:

- A. Possible approval of Capacity Assurance forms submitted by Talking Rock Land, LLC for Talking Rock Ranch, phases 7 and 9D amended. Mr. Busch stated that after talking to legal counsel, it was determined that the District was responsible for filling out the Capacity Assurance forms. Mr. Busch went over the figures with the Board and the forms were appropriately filled out. Mr. Summers made a motion to approve the Capacity Assurance forms submitted by Talking Rock Land, LLC for Talking Rock Ranch, Phases 7 and 9D amended. Mr. DeSantis seconded the motion. The motion passed unanimously without further discussion.
